#### "Your Test Results Are In"

A few years ago, I suffered an acute pancreatitis attack just before our church service, which left me lying in the narthex, writhing in unbearable pain. What made the pain worse

was that the Pastor was out of town and had asked me to deliver the message that Sunday. I was literally walking into the sanctuary when the attack hit.

I thought I had prepared a great message, but clearly, the Lord had other plans. The ambulance took me away, and after a week in the hospital, I was discharged with the doctors explaining that they had no idea why the attack occurred, so they ordered more tests.

Not long after, I received an email from the infamous "MyChart" account, notifying me that my test results were available. My greatest fear was that I had pancreatic cancer, as anyone familiar with this type of cancer knows that it's usually accompanied by the chilling diagnosis: "you don't have much more time."

I logged in and noticed a standard warning that my personal physician had not reviewed the results. But that didn't stop me—after all, I'm an "Internet MD."

As I read through the detailed results, one sentence shook me to my core. A doctor at the hospital had reviewed the results and added a note to my physician, suggesting that a particular "marker" could be indicative of pancreatic cancer. I froze as I read that line over and over, unable to move for the rest of the afternoon, until I received a call that evening from my physician.

He said simply, "Jim, everything looks good; we'll just need to watch your diet and keep an eye on things." Stunned, I paused and asked, "But there was a note about a marker indicating the possibility of cancer?" He replied, emotionless, "Oh, that was a misinterpretation of a certain test. You don't have any cancer cells."

He had no idea that I had already diagnosed myself, given myself two months to live, and was trying to figure out what to do with my remaining time on Earth. It was a surreal moment, but I am clearly blessed to be free of any terminal disease.

You might be wondering: what does this have to do with law enforcement, security, values, and the training and education provided by the ICJE? Well, I thought about my experience with cancer tests as I listened to a series of podcasts about FBI whistleblowers while researching topic ideas for this month's newsletter.

One after another, individuals with legitimate concerns about the integrity of investigations or those in management positions within the FBI shared their stories, all of which had a common "marker." Although many of these cases were separated by years or distance, the path of retribution was eerily similar.

It was as though each whistleblower represented a different lymph node within the FBI's larger body, alerting society that a biopsy had confirmed cancer within the Bureau at the management levels. We just didn't get the test results in time, or perhaps we were too entrenched in our personal feelings to recognize the message.

As I dug deeper into the allegations involving FBI Agent Steve Friend, Analyst Marcus Allen, SA Garret O'Boyle, SSA Zach Schoffstall, Kyle Seraphin, and many others, it became clear that there are enough "markers" to indicate that the infection isn't isolated to certain individuals but has spread throughout management. SSA Schoffstall described the current crisis as a lack of integrity within the management ranks, with a culture of corruption infecting every level of leadership.

I don't want to believe it could be that bad, but I think the patient (the FBI) requires treatment—radical measures to address generational leadership corruption that has been hidden from public view. I wasn't a fan of the Bogino pick, until I listened to Zach Schoffstall's interview today. He described what happened to him and two other agents when they refused to sign an affidavit supporting a search warrant request they knew to be inaccurate.

The cancer has clearly infected most—though not all—of the management. Only time will tell if the Bureau can restore its reputation for integrity, regardless of political affiliation. Outsiders are necessary for this process. We'll see if the current Director and Assistant Director can cure the patient, or if they too will be corrupted by forces uninterested in the Bureau's long-term health.

The test results are in, and time will tell if the patient recovers.

**Note**: I use the above cancer/patient metaphor with this disclaimer: Nothing in my metaphor can be compared to the physical and emotional pain of actual medical conditions and I have the utmost empathy for those dealing with medical challenges. My family has lost too many to cancer, but I hope you understand my comparison is for illustration purposes.

\*Also, for full transparency my career included a time in which I had to provide an affidavit outlining allegations of wrongdoing in the Bureau when I was a Special Agent, and detailing the resulting threats and fallout I received. So, I may be biased in my evaluation of the current whistleblowers, but if you really dig into the current situations, looking past the sound bites, I think you will have similar feelings that change is needed.
